### **MANAGER'S REPORT**



Dear members,

I thank all of our continuing, departing and new staff led by Charlotte Smith, for their outstanding contribution to the work of the year as VANISH:

• Built a positive relationship with Attorney

General Jill Hennessy, and the DJCS; and

• Lived and thrived through the COVID-19 pandemic.

VANISH's membership survey yielded very positive feedback and offered clear guidance for ways of making connections with members even stronger in the future. Membership now stands at 924, up from 871 this time in 2019.

In 2019/2020 VANISH advocacy has meant:

- Preparation of a comprehensive submission to the current Inquiry into Historical Forced Adoptions;
- Providing encouragement and support to members who wanted to prepare their own Inquiry submissions;
- Urging the Victoria Government to find ways of addressing discrimination against the LGBTQIA community in the ART Act 2008 (Vic) that endeavours to protect from the negative impacts of large numbers of children and siblings being created through ART; and
- Continuing work to promote replacement of the outdated 1984 Adoption Act and in particular to make provisions for integrated birth certificates.

2020/2021 sees VANISH face fresh challenges:

- New strategic thinking in response to the forthcoming COVID-19 normal world;
- Ensuring VANISH and our members' voices are heard during the Historical Forced Adoptions Inquiry; and
- Negotiating long term funding arrangements for the work VANISH will undertake for DJCS and their partners.

I thank all CoM members for their work, in particular noting the lasting, significant contribution retiring member Lyn Moore has made.

Dear members,

It gives me great pleasure to report on what has been an extraordinary year. Victoria has faced unprecedented challenges with COVID-19 and we are now relieved and hopeful as the state opens up again.



The lockdown in Melbourne dramatically changed how we work and the staff team have had to be agile yet steadfast to minimise disruption to our services. Searches have been progressed despite the closure of public records offices, support has continued by phone and through support groups offered online. Feedback from our Service Users indicates we have continued to make a positive impact on their lives and I congratulate the team on their remarkable adaptability and commitment.

We have engaged positively with our existing and new funding partners during a year of considerable movement. The Department of Justice and Community Safety is reshaping adoption services, work that is still ongoing. The donor conceived search service was transferred from the Department of Health and Human Services to VARTA and Open Place has transitioned from Berry Street to Relationships Australia Victoria.

This year we farewelled our two longest serving staff members Mary Rawson and Elizabeth Tomlinson, who have been the backbone of VANISH and made an enormous contribution to our work. We acknowledge them both in this report.

We are now well into financial year 2021. We eagerly await the Victorian Inquiry into Historical Forced Adoptions, we anticipate work commencing on a new Adoption Act, and we look forward to continuing to provide our unique and important services to people affected by adoption, state wardship and donor conception.

I am very grateful to the Chair Simon Pryor and the rest of the Committee for their leadership and unwavering support this year.

### SEARCH AND SUPPORT SERVICES

#### Overview

During the 2019-2020 financial year, VANISH registered fewer searches than last year and responded to more requests for information and support. Due to COVID-19 new searches dropped dramatically in March (6) and April (7) but increased again in May (23) and June (19). The following section provides details about new registrants, new searches, closed and completed searches and the number of instances of support, information and referrals.

#### **New Registrations**

In 2019-2020, there were 184 new registrants (compared to 215 in 2019).


- 157 registered for search assistance to search for relatives (187 in 2019).
- 27 registered for the VANISH counselling service (28 in 2019).

#### **Status of New Registrants**

The breakdown of new registrants by status below shows that the majority were Adopted Persons:

- 101 Adopted Persons
- 2 Natural Parents
- 6 Child of Adopted Person
- 24 Agency searches on behalf of Natural Parents (2), Adopted Persons (19) and Forgotten Australians (3).
- 24 VARTA requests on behalf of Donor Conceived Persons, Donors and Parents of Donor Conceived Persons.

The age range of new and existing registrants is from 25 to 81 years. The chart below shows the number of new registrants over the past four years.




#### **New Searches**

There were 241 new searches registered this year compared to 305 in 2019. 156 were on behalf of new registrants (187 in 2019) and 85 on behalf of returning service users (118 in 2019). The status of the person sought was as follows:

- 153 Natural Parents of Adopted Persons and Forgotten Australians
- 55 Natural Relatives of Adopted Persons and Forgotten Australians
- 6 Adopted Persons
- 27 Donors or Donor Conceived Persons

The Chart below shows the Status of Persons Sought for the past four years.



The difference between the number of registrants and the number of searches is that some registrants request more than one search, for example where a person searches for their natural mother and their natural father or if a relative is found deceased then a new search for a living relative may commence.

### **SEARCH AND SUPPORT SERVICES**

#### **Completed Searches**

220 searches were completed this year:

- 105 Found living (125 in 2019)
- 41 Found deceased (50 in 2019)
- 12 Found records (9 in 2019)
- 62 Not Found (31 in 2019)

#### **Closed Searches**

117 searches were closed this year. Searches might be closed after discussion with the searcher due to e.g. not having enough information, the Service User deciding not to proceed for a range of reasons, or the Service User having completed the search themselves.

- 41 were closed after discussion with the Service User (20 in 2019)
- 76 closed due to not no paperwork being received from the Service User after registration, or due to no further contact with the Service User (50 in 2019)

NB Completed and closed searches relate to previous active searches as well as those registered this year.

#### **Agency Searches**

VANISH continued to have contractual arrangements to conduct searches on behalf of clients of several Agencies: Open Place, VARTA, Adoption Information Services (formerly FIND) and Anglicare. In addition, VANISH has continued to conduct searches on a reciprocal basis for post-adoption agencies in New South Wales, South Australia and Western Australia New Zealand, England.

These arrangements are of many years standing and are invaluable as they have enabled many long and difficult searches to be completed. The search team are particularly grateful for the generous assistance our interstate colleagues provided during the lockdown and sincerely thank Jigsaw WA, PASS SA and Jigsaw QLD for their support.

#### **Support, Information and Referrals**

Requests for support, information and referrals via telephone, email, letter and face to face, continued to be a significant aspect of the work of the VANISH search and support team during the course of the year. VANISH received 1598 requests for information, support and referrals from service users this year which is an increase from 1389 last year. The following figures provide a breakdown:

- 1423 instances of information and support provided (1277 in 2019).
- 166 referrals made to other agencies and services and to counsellors (112 in 2019).
- 329 professionals assisting clients affected by adoption and state wardship (257 in 2019).

#### **Education and training**

There were 232 contacts relating to community education and professional training this year, significantly fewer than 582 last year.


- 222 community education contacts, including health and mental health practitioners and historical societies (511 in 2019)
- 10 attendees at Professional Training (71 in 2019)

#### **Enquiries**

VANISH registers on the database enquiries which require detailed responses and/or on-going support. Enquiries this year were predominantly requests for information concerning how to find a relative who was adopted or how to get adoption records so as to search for mothers, fathers and other family members. There were also a several requests for information about the Victoria Inquiry into Forced Adoption. Requests for support most frequently included dealing with relationship difficulties concerning reunion or managing relationships between all family members.

### **SEARCH AND SUPPORT SERVICES**

The chart below shows VANISH support, information and education services delivered and the proportion for each type of service. Not all services are directly comparable so this chart is indicative only.



#### Counselling

Over the year we responded to a steady stream of requests and provided counselling to 42 Service Users from metropolitan Melbourne, rural/regional Victoria and interstate as well as making referrals to the therapists on our list of counsellors experienced in supporting individuals affected by adoption.

The details of counselling registrants and sessions are shown in the breakdown and chart below:

- 27 new individuals registered for the counselling service.
- 15 existing service users received counselling
- 153\_counselling sessions were conducted in person and by telephone to individuals dealing with a range of issues concerning their adoption or the adoption of their now adult child.

#### **Support Groups**

This year the Melbourne Mixed Group and two Adoptee Only groups, one funded by VANISH supporters through a Chuffed campaign, continued to operate up until the restrictions. From then on the Adoptee Only Groups continued online. In Ballarat meetings occurred when possible while the Albury-Wodonga group also went online. These groups proved an important source of support and connection during lockdown. A total of 325 attendances were recorded as follows:

### YOUR COMMUNITY

#### **Without Consent**

Last November, VANISH and ARMS (Vic) arranged an excursion for members and guests to view the *Without Consent* exhibition at the National Wool Museum in Geelong where we were joined by a group from Tasmania. This special event was made possible with the generous support of National Archives Australia (NAA) and the National Wool Museum. This was the only showing of the exhibition in Victoria so it was an important opportunity for the community.

Jo Fraser, Secretary of ARMS was our MC for the event. Padraic Fisher, CEO of the National Wool Museum gave us a warm welcome then Caroline Webber, Director of Public Programs at NAA provided an overview of how the exhibition was designed, curated and displayed. Hon Nahum Mushin AM shared an overview of forced adoptions, summing up by saying, 'This exhibition is a record of events which occurred in Australia which we must never forget. I'm constantly reminded of the phrase 'Lest we forget', which is used in another context, it is very relevant here. ... This exhibition would not have existed without all the things that are in it and they are there as a result of people who have actually experienced it. That this exhibition is here is because of those who keep going, keep going in a most extraordinary way.'



After lunch Charlotte Smith, VANISH Manager, invited community representatives to respond. Marie Meggit, Chair of ARMS (Vic) and Tricia Lester, Secretary of VANISH led the responses then others shared their feedback. Their comments were a strong testament to how powerfully validating the exhibition is for people with a lived experience. It is also highly educational for people not familiar with Australia's past adoption practices.

VANISH has advocated to the NAA that *Without Consent* not be archived yet, especially given its potential for education and advocacy during the current Inquiry into Historical Forced Adoptions.

### **Anniversary Event**

On 25th October 2019, VANISH members and representatives attended a gathering organised by ARMS (Vic) at the statue "Taken Not Given" in St Andrews Place, Melbourne, to commemorate the 1st Anniversary of its unveiling and the 7th Anniversary of the Victorian Apology for Past Adoption Practices. Marie Meggitt made a powerful speech reminding us all of the dark journey of adoption and the profound loss and grief that is the lived experience of those affected. After the ceremony all gathered at the nearby café and shared their stories.





### YOUR COMMUNITY

#### **DNA Presentations**

#### **DNA Downunder, Melbourne & Sydney**

In August 2019 DNA Downunder events were held across Australia, with international experts in DNA testing presenting on a range of topics.

At the Melbourne event VANISH had a table which received a constant stream of visitors with questions about our services and other adoption matters.

At the Sydney event which was the largest DNA Downunder gathering, VANISH Manager Charlotte Smith presented on "Making and managing contact in the context of adoption and NPE" which was well received by the audience of DNA users and genealogists alike. Making contact with the correct person and sensitively, is one of the most pressing challenges with DNA testing and participants were keen to hear more about ways to go about this and about VANISH search and support services.

#### **Albury-Wodonga**

In response to a request by participants of the Albury-Wodonga support group and to increasing demand to understand the complex topic of DNA testing for finding unknown family, VANISH organised a presentation and questions and answers session in September, facilitated by Rose Overberg.

Rose is a Victorian based Donor Conceived Person who has assisted numerous adopted people and donor conceived people to identify their relatives or ancestry through analysing their DNA results.

The event was well attended and the session stimulated lots of questions and discussion. Topics covered were: what is DNA and how is it used for finding unknown family; using DNA and family trees to be a DNA detective and finally, how to manage expectations and contact with genetic relatives.

### **Writing As Therapy Course**



Over the past six months VANISH has offered Writing As Therapy courses run by Dr Sian Prior, a Melbourne based writer with a PhD in creative writing who teaches creative writing at RMIT.

Originally the course was to be in Melbourne, however due to COVID we asked Sian to adapt to online. This resulted in smaller groups but savings on the venue and catering meant we could offer four courses, two each for Mothers and Adopted Persons. A total of 32 participants attended, some of whom would have faced barriers in physically attending a Melbourne event.

We are very grateful to Sian, for her adaptability and sensitive approach as she shared her story, insights and expertise with participants. We are also grateful

to the COMPASS program (Relationships Australia) for the small grant for this course.

Here is some participant feedback. All comments are published with permission, anonymously.

I thought she (Sian) did a great job creating a safe space for people to think about their writing and provided the opportunity for people to share but only if they felt comfortable. It was good to hear about her experiences with writing and the different ways to think about and approach writing. Thank you!

Writing a journal - not as challenging as I thought.

It was great to share stories with others and to be given some basic structures and writing exercises to work on. I liked the resources Sian gave us - I have checked out a few of the books already. Overall it was inspiring and useful.

An inspiring opportunity to engage with a very practical resource for self care and reflective practice.

### **YOUR VOICE**

### Advocacy by VANISH

This year VANISH has undertaken a significant amount of advocacy on behalf of our members and community. Our advocacy positions are drawn from long experience of working with people with a lived experience, whose voices are front and centre in our submissions and media work. Letters and submissions to policy makers are the result of a team effort by VANISH Committee members with Manager and staff input.

#### **Inquiry into Historical Forced Adoptions**

In May last year, Victoria's Attorney General the Hon. Jill Hennessy, announced a new parliamentary Inquiry into support services and responses to the issue of historical forced adoptions in Victoria.

The Inquiry Committee Chair, Natalie Suleyman said the Inquiry was "an important opportunity for community members to provide information that will enable the Committee to assess what support has been provided and to make recommendations going forward".



VANISH made a substantial submission into the Inquiry, seeing it as an important opportunity to put on record past practices, their impacts, community action, legislative reform, the apologies, services provided and the gaps. VANISH made 30 recommendations, including the following:

- \* There be a sensitive redress scheme which includes the removal of the statute of limitations so that the responsible institutions can be taken to court.
- \* Natural parents be afforded the same rights with regard to Registries of Births, Deaths and Marriages as adopted persons, so that they are able obtain their adult child's marriage, change of name and/or death certificates, if they exist.
- \* Cost-free Integrated Birth Certificates be made available to adopted persons who want them.

- \* Adoption discharges be a simple, no fault procedure and this be publicised.
- \* Government provide adequate funding for the delivery of a full suite of services for people affected including counselling and support groups.
- \* Regional outreach programs be funded and implemented to improve access for regional and rural Victorians.
- \* Government funds research into various aspects of past adoption practices, particularly impacts across the lifespan, and contact and reunion outcomes.

Public hearings are due to commence as soon as restrictions allow. The report is due in December but likely to be delayed into 2021 due to COVID.

#### **Donor Conception Advocacy**

In July, VANISH made a submission in relation to a proposed amendment to the ART Act (2008) to change the limit from 10 women per donor, to 10 families. This amendment aims to address discrimination against the LGBTQIA community e.g. where same sex female couples both wish to conceive children and want them to be biologically related.

In our submission we expressed support for removing discrimination. The concerns we raised relate to undermining the original purpose of the 10 women limit which is to reduce the possibility of consanguinity between donor conceived people and to limit the number of children born as a result of each donor's donation, as this is an important factor for the emotional wellbeing of donor conceived individuals. VANISH recommended reverting to the original proposal of replacing the 10 women limit with a 5 family limit as this would address discrimination and go some way to limit the number of children born of the same donor parent. The current limit of 10 women is likely to result in 20 to 30 siblings for a donor conceived person. Changing it to a 10 family limit could result in doubling or trebling that given the dynamic nature of families and the high rate of separation and repartnering in Australia.

VANISH noted the parallel with adoption whereby even though the Act states that the rights of the children to be born are paramount, policy and practice were and are developed largely in response to the needs and demands of people wanting children and the industry that supports them. There seems to be little concern for, or listening to, the children affected by these policies who are now adults.

### **YOUR VOICE**

### **Integrated Birth Certificates**

In 2012 the Senate Inquiry into Former Forced Adoption Policies and Practices recommended Integrated Birth Certificates be implemented. The Victorian Government responded with 'support for the development of an integrated birth certificate in conjunction with national reforms relating to documentation and provisions of birth and adoption records'. Since then, the Victorian Law Reform Commission (VLRC) undertook a review of the Adoption Act 1984. The Commission heard a range of views and in its final report (2017), recommended Integrated Birth Certificates be implemented.

One important principle is that adult adoptees can choose whether or not to apply for one. This choice is an important factor for individuals who had no agency in their adoption. Some might not choose to apply for these certificates, but making them available for those who do is about righting the wrongs of the past. "For many people affected by past closed and forced adoptions, the amended birth certificate symbolises the serious problems they see with adoption. Their birth certificates represent erasure of their past and fabrication of their birth; a re-writing of their identity; and dishonesty and injustice which must be corrected. The Commission was told 'adult adoptees have to live with [this] on a day to day basis'" (VLRC p96).


Following an article in VOICE newsletter about NSW introducing Integrated Birth Certificates, VANISH members sent in their views. Some are below: "My thoughts are I would like the option. I hated the fact that my original birth certificate got cancelled, I hate the fact that my birth certificate has adopted stamped all over it. My original certificate that had Schedule 5 at the top (which no one knew what that meant) had to be cancelled - but it meant a lot to me, if I want to apply for a full birth certificate to go overseas this was not good enough and it was cancelled - just like my birth really - cancelled out." Kelli, adopted in 1972

"As an adult, I would love to have the option to see my entire history on the one page and feel that my birth family (both of whom I've met) is included. I think it provides a visual representation of the kind of chaotic mess of information that adoption leads to. I really like the terms 'before adoption' and 'after adoption' which clearly acknowledges all parties. It would also provide future generations with information of their true biological heritage.

I sincerely hope that integrated birth certificates soon

become reality in Victoria for all adoptees and donor conceived people." Adoptee, adopted in 1965.

"It would be so meaningful to me to be able to use an integrated birth certificate. An integrated birth certificate, with both sets of parents on my birth certificate, would allow me to feel that who I am is legitimate, that I am not a dirty secret to literally be erased with a new and false birth certificate. It would allow me to be more confident and more truthful about who I am. There is no shame in having more than one set of parents, or any of the new family set ups we see emerging today. What is shameful is living in a society that can only see parents in one form, where parents only feel legitimate if a child's biology is erased, all to ensure we conform to this western notion of a nuclear family. I'm so happy to see NSW lead the way with integrated birth certificates, it's well past time for Victoria to get on board too! " Cheyne, adopted in 1980.



NSW Proposed Integrated Birth Certificate


VANISH wrote to the Victorian Attorney General Jill Hennessy pointing out that it is eight years since the Senate Inquiry recommended Integrated Birth Certificates and the community should not have to wait any longer for them to be implemented. In our letter we also raised the issue of the New Adoption Act, explaining that some people affected, particularly Natural Parents, are concerned they will not live to see the discrimination removed. We urged the AG to direct this important work recommended by the VLRC be commenced without further delay.

### YOUR FEEDBACK

This year we carried out our Service User Satisfaction Survey for people who had received a service in the last three years. We received 101 responses with wonderful feedback and very helpful insights for which we thank everyone who participated. Below is a snapshot of the results.

#### Respondents


86% of respondents came from two main age brackets, 47% from the 46-60 age bracket and 39% from the 61-75 age bracket.



The majority of respondents (77%), were an adopted person, 13% were a natural mother, 4% a Forgotten Australian, 4% an adoptive parent, 1% a natural father and 1% a donor conceived person. Those who responded "other" (7%) included a sibling of an adopted person, a child of an adopted person and an adopted person adopted by a step-parent.


54% of respondents live in Greater Melbourne, 12% in regional centres, 12% in rural Victoria, 16% interstate and 2% overseas.

The most common engagement with VANISH by those surveyed was for search assistance (63%) followed by information (40%), support (34%), support groups (27%), counselling (19%) and workshops/short courses (9%).




#### **Service Performance**

Overwhelmingly (95%) respondents rated the quality of VANISH's services as either excellent or good.




Respondents also rated the extent to which their needs were met highly with 91% as excellent or good.




#### Search & Support

The feedback regarding the search service highlighted the high quality of work the team does, rating them consistently as either excellent or good in categories such as being respectful to individual circumstances (93%), being able to 'hear' or understand the feelings of the service user (92%) and how they would rate the workers explanation of the search process (93%). Suggested improvements to the search service were to have a more national approach, a service for people using DNA testing, and to have more staff.




92% of respondents who said they accessed support through VANISH rated this support as either excellent or good. This is shown in the chart below.




#### **Support Groups**

Of the people who attended support groups, 96% rated their experience as excellent or good. Common positive experiences were that the people attending felt validated, able to find people with a shared experience to their own and not feeling so alone.




#### Counselling

Of the people who utilised the counselling services 95% of respondents rated the experience as excellent or good. A significant number or people felt being supported and heard by a caring and understanding professional was the most positive outcome. Others referred to the positive impact in terms of outcomes in their reunions and relationships.




#### Describing the service

Respondents were provided with a list of phrases and were asked to identify those which best described VANISH. They were able to identify as many from the list as they felt appropriate. The responses are provided in the chart below. The most frequently chosen phrase was "feel you are not alone" closely followed by "have a better understanding of the adoption experience". The "other" responses included developing a better understanding of the sibling experience, being assisted to know and understand how to balance their identity between the adopted and biological selves, and supporting others on their adoption journey.



When invited to pick words to describe the VANISH service, respondents overwhelmingly picked the positive descriptors, as shown in the chart below.



#### Research

This year the survey included a new question "Are you interested in doing more detailed surveys from time to time about different aspects of your lived experience, for example contact, reunion, relationships etc? Of the 87 respondents who answered this question, 60% said yes. This is very positive given the dearth of research and we will follow up on this next year.

## Notes to the Financial Statements for the Year ended 30<sup>th</sup> June 2020

#### 1. Summary of Significant Accounting Policies

#### **Basis of Preparation**

In the opinion of the Committee of Management, the Association is not a reporting entity since there are unlikely to exist users of the financial report who are not able to command the preparation of reports tailored so as to satisfy specifically all of their information needs. These special purpose financial statements have been prepared to meet the reporting requirements of the Associations Incorporation Reform Act 2012 and the Australian Charities and Not-for-profits Commission Act 2012.

The financial statements have been prepared in accordance with the recognition and measurement requirements of the Australian Accounting Standards and Accounting Interpretations, and the disclosure requirements of AASB 101 Presentation of Financial Statements, AASB 107 Statement of Cash Flows, AASB 108 Accounting Policies, Changes. The financial statements have been prepared on an accruals basis and are based in Accounting Estimates and Errors and AASB 1054 Australian Additional Disclosures.

The financial statements have been prepared on an accruals basis and are based on historical costs modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

Significant accounting policies adopted in the preparation of these financial statements are presented below and are consistent with prior reporting periods unless otherwise stated.

#### 2. Summary of Significant Accounting Policies

#### **Cash and Cash Equivalents**

Cash and cash equivalents comprises cash on hand, demand deposits and short term investments which are readily convertible to known amounts of cash and which are subject to an insignificant risk of change in value.

#### **Provisions**

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

#### **Employee Benefits**

Provision is made for the association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be wholly settled within one year have been measured at the amounts expected to be paid when the liability is settled. Employee benefits expected to be settled more than one year after the end of the reporting period have been measured at the present value of the estimated future cash outflows to be made for those benefits. In determining the liability, consideration is given to employee wage increases and the probability that the employee may satisfy vesting requirements. Changes in the measurement of the liability are recognised in profit or loss.

#### **Property, Plant and Equipment**

Property, plant and equipment are carried at cost, independent or association's valuation. All assets excluding freehold land, are depreciated over their useful lives to the business. Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

#### **Revenue and Other Income**

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the entity and specific criteria relating to the type of revenue as noted below, has been satisfied. Revenue is measured at the fair value of the consideration received or receivable and is presented net of returns, discounts and rebates. All revenue is stated net of the amount of goods and services tax (GST).


#### Interest Revenue


