The Commonwealth Government has arranged **three events in Canberra** to commemorate the 10th anniversary of the National Apology for Forced Adoptions.



On 21 March from 6pm-7.30pm the National Archives of Australia (NAA) will host Saying sorry: Do national apologies change the world?, a panel discussion moderated by Paul

Barclay from ABC's Big Ideas with guests former minister the Hon Jenny Macklin, the Hon Nahum Mushin AM, Professor Michelle Arrow and Ms Rosemary Baird. The discussion will be uploaded to the NAA's website and aired on Radio National at a later date. On **21 March from 7.30pm** there will be a dinner event for representatives nominated by support and advocacy organisations and Forced Adoption Support Services operating across all states and territories. Attendees will then be welcomed to a morning tea in Parliament House with Parliamentarians. Births, Deaths & Marriages

Over the past year, access to Births, Deaths & Marriages (BDM) for the purposes of searching has undergone some changes and further changes are expected through the upcoming review of its Access Policy. Where previously, adopted people would apply to BDM for the birth, death, marriage, or change of name certificates relating to their natural parents, applications for information are now submitted to Adoption Information Services (AIS). We are currently trialling this new pathway and are grateful to the AIS team for their assistance as we navigate the new procedures.

The change enables information to be obtained without individuals having to apply and pay for certificates which is a positive outcome, especially for people whose searches have been hampered due to financial constraints. However, the fact that the actual certificate is not provided means that other potentially valuable information is not available which could limit the likelihood of finding the person sought. We have been advised that if a certificate from BDM is still needed for searching purposes, or wanted for sentimental or other reasons, a request can be made to BDM and will be assessed on a case-by-case basis until the Access Policy is changed.

For mothers and fathers (natural parents) this is not so different to current practice because unfortunately, they were never given the right to apply to BDMs for certificates pertaining to their adopted daughters and sons. Equal rights for mothers and fathers in terms of access to information is something VANISH has long advocated for, particularly since the legislation changed to give them the right to identifying information in 2013.

We had expected the review of BDM's Access Policy to be undertaken at the end of last year, however the post-election Machinery of Government changes, which saw BDM moving to the newly formed Department of Government Services, are likely to have delayed this. We have also been assured that the review will involve an opportunity for consultation.

VANISH will continue to represent our members and service users in terms of rights to privacy and rights to information.

Birth Certificates

Another area we have been advocating on relates to adding the father to an adopted person's birth register and certificate. This is important because it will not be possible to have the father stated on the new Integrated Birth Certificate being introduced in October, if he is not on the birth register.

According to the advice we received, for adoptions prior to 1985 the evidentiary threshold is lower and there is no need for a DNA report, but this has not been the experience for some of our service users. We are currently seeking clarification and advocating for clear and equitable procedures for adding fathers. We will keep you informed of any news as we are aware some individuals may want to do this in readiness for applying for their Integrated Birth Certificate.

Exceptional Circumstances Fund

The Victorian Government's Exceptional Circumstances Fund has continued to provide one-off payments to mothers facing exceptional circumstances. VANISH has assisted mothers to successfully apply for up to \$10,000 which in some cases has been life-changing for them. Exceptional circumstances can include:

- terminal illness
- critical illness
- diagnosed mental illness
- requiring surgery for mobility issues, chronic health conditions or other elective surgery
- having one or more chronic conditions
- having experienced an injury or other debilitating event that has materially impacted on your physical or psychological wellbeing
- other exceptional circumstances that are likely to significantly impact you in the next 12 months.

If you are not sure if you qualify and would like to discuss this with us, please call VANISH and speak with one of our team. If you would like support in completing or submitting your application form we would be happy to assist you. In some locations we can arrange face-to-face meetings or home visits. VANISH has also produced a supporting letter you can hand to your medical professional which describes the scheme and how they can support you.

Free DNA Kits from MyHeritage

Applications are now open for *DNA Quest*, MyHeritage's pro bono initiative to help adoptees and their families reunite through genetic testing. **Applications close on 17 March, 2023** and preference will be given to people who are not able to afford genetic testing.

For more information or to apply for a free DNA kit, visit dnaquest.org. Decisions will be made approximately one month after the 17 March deadline and applicants will receive an email informing them of the outcome of their application, with kits mailed out shortly thereafter.

Northern Ireland's investigation into institutional abuse extends to Australia

As Northern Ireland's investigation into physical and sexual abuse at mother and baby homes, Work Houses and Magdalene Laundries continues, the search for survivors has been extended to Australia, assisted by the Australian Federal Police.

Police are appealing for mothers who were taken to one of these institutions to give birth, people who were adopted from, and people who visited, or worked in them between 1922 and 1990, to come forward.

Detective Superintendent Gary Reid, operational lead for the investigation, said: "If you believe you were the victim of abuse or other forms of criminality in any of these Northern Irish institutions, or know somebody who was, or if you witnessed anything suspicious, please contact us, we want to hear from you."

Royal Women's Hospital remove fees for accessing medical records

Royal Women's Hospital (RWH) has removed fees for accessing medical records relating to historical adoptions. According to its website, the RWH holds obstetric medical records of women whose babies were adopted post 1960, and for adoptions between 1888 and 1959 it can provide the date, time, weight and length of babies delivered. The application form for Medical Records Relating to Adoption has also been updated. It can be found at this link https://bit.ly/RWHappform

If you accessed your records prior to July 2021 and have been charged a fee, you can apply for a refund by contacting the hospital's Freedom of Information team by emailing foi@thewomens.org.au or by calling 03 8345 2610.

Anglicare Victoria apology for historical adoption practices

VANISH was recently advised that Anglicare issued a new apology for historical adoption practices last year (12 May 2022), which you can read here: https://bit.ly/AnglicareApology

VANISH is pleased that this apology is more in line with the Senate Inquiry recommendation in that Anglicare "unreservedly" takes responsibility for the lifelong impact of adoption practices. This is unlike former apologies from the Anglican Church and other non-government institutions, which have minimised the extent and impacts of past adoption practices and/or their involvement.

However, we are not aware of how and when this apology was delivered, or how much consultation was undertaken with the individuals and families it is offered to.

In our submission to the Victorian inquiry we emphasised the importance of getting apologies right, the harm that can be caused when this does not happen and the healing that occur when it does.
